Conditions

- 1. COPYRIGHT of the programme, route descriptions and maps are the sole property of COMPANY NAME. Changes in the programme or route descriptions may only be made with the written consent of COMPANY NAME.
- 2. Route descriptions, maps, App access (link and credentials) and a list of accommodations will be provided by COMPANY NAME once in the language agreed at the start of the season (deadline will be I month prior to the first confirmed departure). AGENCY is responsible for the reproduction of maps and trip documents (either digitally or printed) and will see to it that clients receive their documents on time. If AGENCY prefers to have documents delivered at the first hotel, a fee of 30€ will be charged for each booking to cover printing and postage, unless clearly specified in the included section in the price list attached.
- 3. The route descriptions and travel information have been compiled with great care and precision. However, it is possible that clients may experience small changes during their holiday, or notice errors unforeseen at the time of writing. The information is provided "as is" and we accept no responsibility for any loss, injury or inconvenience experienced as a

result of this information.

4. Prices for the current year are fixed for the standard programme, as specified in separate documents (Price List). Rates given are net prices in EUROS, unless otherwise specified, and payment is to be made in EUROS.

5. In Summer / Autumn each year, COMPANY NAME will provide prices for the following season depending on the beginning of the season, unless AGENCY has communicated an earlier deadline. Rates given are net prices in EUROS, unless otherwise specified, and payment is to be made in EUROS.

6. If changes to the programme occur during the season due to natural disasters, closing down of accommodations or other unforeseen 'force majeure', COMPANY NAME will communicate the changes as soon as possible to the AGENCY. If these changes result in a change in the package price, these will only apply to new bookings (sent after the changes have been communicated to the AGENCY).

7. All bookings are on request and should include details such as the Clients' full name and date of birth, room preference, height, dietary preferences and medical essentials. These data are subject to European rules for data protection.

8. A contact phone number from clients and reachable when travelling in COUNTRY is required with the firm booking form for operational reasons (automatic check-ins, later arrivals, etc). This contact number will not be used by any means for marketing purposes by COMPANY NAME.

9. Client room preferences are treated as such and cannot be guaranteed. This is especially important in the case of double rooms, where clients' preference will be requested (one double bed OR two twin beds, placed side by side or separately) but depending on availability at hotels, this preference MAY NOT ALWAYS BE POSSIBLE.

In the case of dietary preferences, we can only guarantee restrictions based on medical conditions (such as diabetes, gluten intolerance, etc.) or common diet choices (such as

10. AGENCY should inform clients that this Request is not an availability check but is considered a firm booking and will be treated as such by both parties as soon as COMPANY NAME confirms availability. Cancellation charges may apply if the client cancels the booking after confirmation (see number 16 below, less than 4 weeks before the trip start date).

11. Any changes made by the client (room type, dietary requirements, dates, number of participants, extra nights in the middle of the programme, etc) after COMPANY NAME has sent the final confirmation of the trip to the AGENCY will be charged with a changing fee of 30€. Clients and AGENCY must make sure that all data are correct and definitive at the time of sending the booking request to COMPANY NAME.

12. COMPANY NAME will try to confirm bookings within 3 working days. Confirmation will depend on the availability of programmed hotels.

12.1. If standard accommodation is not available, COMPANY NAME will try to offer alternatives that might involve extra costs or discounts (depending on the price and quality of the alternative accommodation available), or changes in the itinerary or start date. If clients do not agree to the extra costs or change of dates, the booking may be cancelled without costs.

13. Any changes made by the client (room type, dietary requirements, dates, number of participants, extra nights in the middle of the programme, etc) after COMPANY NAME has sent the final confirmation of the trip to the AGENCY will be charged with a change fee of 30€.
